

## **REGULATION OF THE COUNCIL OF MINISTERS**

of 15<sup>th</sup> of December 2008

### **on Kostrzyn – Słubice Special Economic Zone**

Pursuant to Article 4 sub-clause 1 of the Act of 20 October 1994 on special economic zones (Journal of Laws No 42/2007, item 274 and No 118/2008, item 746), it is hereby ordered as follows:

**§ 1. 1.** The Kostrzyn – Słubice Special Economic Zone established under the Regulation of the Council of Ministers of 9 September 1997 on establishment of the Kostrzyn – Słubice Special Economic Zone (Journal of Laws No 135, item 904, as amended<sup>1)</sup>), hereinafter referred to as the “zone”, shall cover the territory marked out within the borders described in the Attachment hereto.

2. The zone shall cover lands with the area of 1186.3803 hectares located within the territory of the following cities: Gorzów Wielkopolski, Gubin, Kostrzyn nad Odrą, Nowa Sól, Poznań, Zielona Góra and municipalities: Barlinek, Bytom Odrzański, Chodzież, Czerwieńsk, Goleniów, Gryfino, Gubin, Karlino, Lubsko, Międzyrzecz, Nowy Tomyśl, Police, Rzepin, Słubice, Strzelce Krajeńskie, Sulecin, Swarzedz and Zielona Góra.

3. The zone shall operate until 31 December 2020.

4. The zone administrator shall be Kostrzyńsko – Słubicka Specjalna Strefa Ekonomiczna S.A. with its registered office in Kostrzyn nad Odrą.

**§ 2.** The revenues of the zone administrator shall be exempted from corporate income tax in the part which is incurred in a tax year or in a following tax year for the purposes of zone development, including the purchase by the zone administrator of real properties or other things for carrying out business activity within the zone and modernization and extension of economic and technical infrastructure within the zone.

**§ 3.** The regulation shall come into force on 30 December 2008.<sup>2)</sup>
